Dear Friends,

It has been truly energizing to engage deeply with our community over the past year to drive forward progress in the first year of our new strategic plan, and to continue to have a lasting positive impact on the youth and families that we serve.

Last year at San Francisco CASA, we launched our new strategic priorities with a focus in the first year of both investing in our people and lifting up the voices and experiences of all those we work with and serve, including young people and their families, CASA volunteers, partners, staff, board members and donors. Our intention is that young people and their families, particularly people of color who have been disproportionately impacted, have agency and voice in their experience of foster care and connected systems.

We were impressed by the successes of our Youth Empowerment Board, which accomplished great feats in their inaugural year. They created a peer-to-peer grantmaking program and awarded grants to 40 transition age youth peers who utilized these resources to further their education and careers, or to support their independent living, health and well-being. They also helped to train new volunteer advocates and shared their work and perspectives with the board of directors and San Francisco's Board of Supervisors.

We've engaged parents to share their experiences in the foster care system with our volunteer advocates in training and now host a weekly session for fathers navigating the child welfare system. Our CASA volunteers have developed the CASA Community Network to support each other and share experiences, resources and tips.

Under the leadership of Chair Allison Eisenhardt, we launched our Leadership Council, a group of long-time champions who share their support and expertise to strengthen the impact of San Francisco CASA. And finally, with your support, we've invested in our staff, with expanded benefits, professional development and a focus on an inclusive organizational culture.

Moving forward, we will prioritize the place we do our work alongside numerous partners, creating an accessible community space to support mission impact in central San Francisco starting January 2024.

We will also continue to invest in our programs, with a particular focus on recruiting volunteers, and developing our aftercare/continuing care efforts, including an expanded tax project, supporting youth beyond their systems involvement, into the transition to adulthood.

We are extremely grateful for your generous support and we look forward to achieving more successes with our community.

Spotlight: Angelina & Kaycee

Angelina joined SFCASA as an advocate in September of 2021 and first met Kaycee several weeks later. In the time Angelina has been Kaycee's CASA, Kaycee has experienced several placements. Angelina has been there for her, supporting her through every placement. When Kaycee was moved further away near Stockton, Angelina consistently drove the long distance to visit her every month. With all the changes, Angelina wanted to support Kaycee educationally, making sure to connect with Kaycee's teachers and receiving weekly emails from her teacher for updates on important events and activities for Kaycee's class. Angelina also scheduled parent-teacher conferences to learn how she could better support Kaycee. After attending a parent-teacher conference, Angelina found out that Kaycee was doing great in choir but was scoring lower in math and reading.

To help improve Kaycee's reading skills, she bought books that Kaycee loved to read – purchasing Junie B. Jones books through SFCASA's Sunshine Fund and dropping them off anonymously at her doorstep. Kaycee was thrilled to have them, even if she was not sure who was dropping them off. It was only later that Kaycee found out Angelina had been the one leaving the books for Kaycee on her doorstep.

Angelina found other ways to be involved in Kaycee's life, even volunteering to be a guest presenter for Kaycee's class. She also spent several months trying to register Kaycee into an after-school program.

In early 2023, Angelina found herself going through a huge change in her own life.

She was getting married and was nervous to share the news with Kaycee. Angelina had been Kaycee's CASA for almost a year and a half, and had become a constant support in Kaycee's life. With everything changing, she wasn't sure how Kaycee would take the news.

Angelina reached out to her SFCASA case supervisor and together, they came up with ideas on what to say to Kaycee.

During their next visit, Angelina and Kaycee went out for shakes at Ghirardelli Square. During the outing, Angelina asked Kaycee when she would see her next. Angelina realized this would be the perfect time to mention the big news. She used the question as an opening to share what she had practiced with her case supervisor.

Angelina told Kaycee that she was getting married and moving to another state. Even though she would be moving away, Angelina shared that she still wanted to be a part of Kaycee's life, now in a more personal way instead of an official way. She let her know that she was not going to drop out of Kaycee's life and wanted to stay in touch with her through phone calls and letters.

When Angelina finished telling Kaycee the news, Kaycee jumped up and gave her a huge hug, stating that she was so happy for her. Kaycee told Angelina that she also wanted to stay in touch with Angelina. They ended the visit by going to Target and buying matching stationary sets so they could write each other letters.

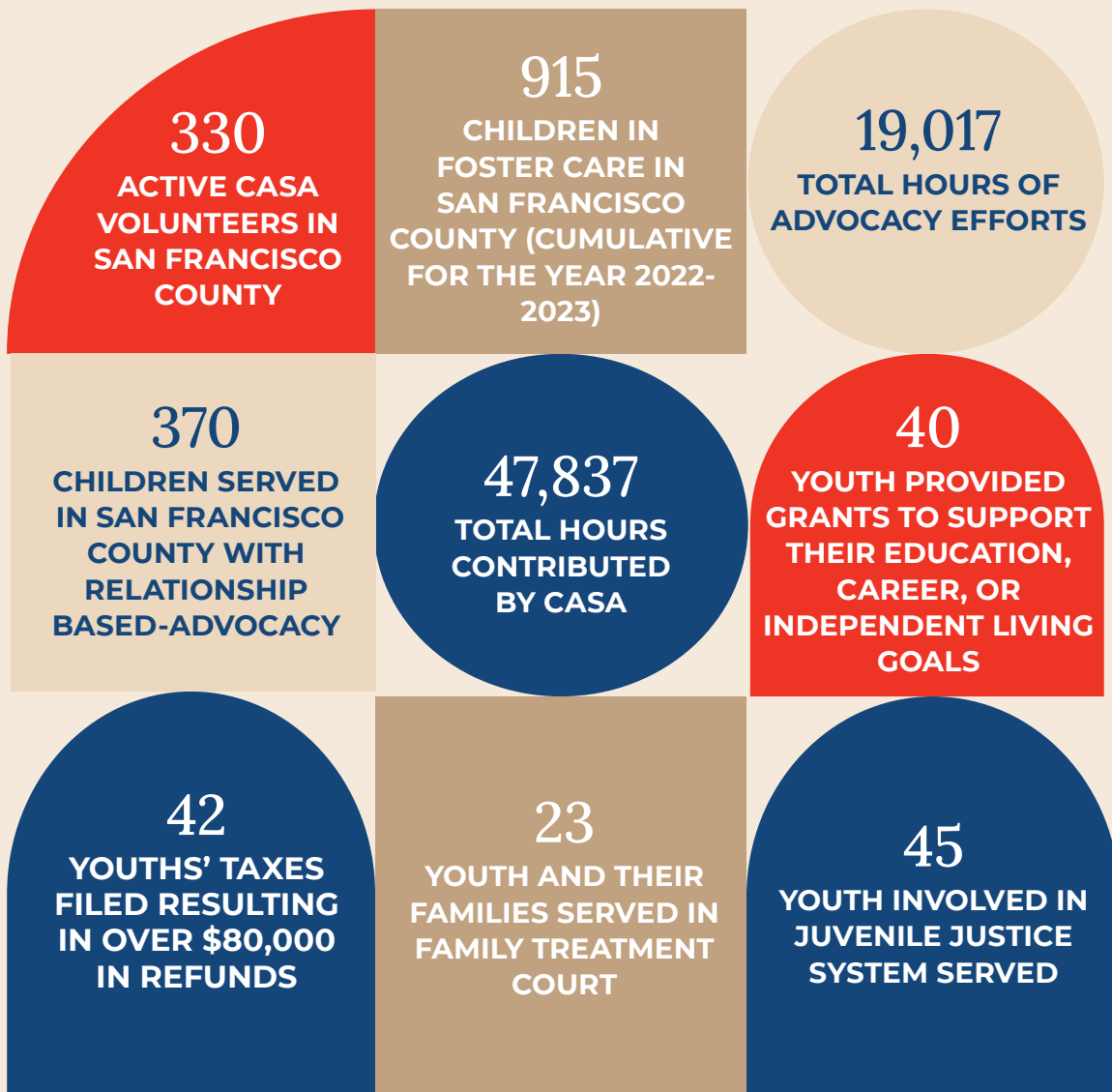
As Angelina dropped Kaycee off at her home, they embraced. They planned to coordinate Zoom calls after Angelina moves, for as long as Kaycee wants them, hopefully for many more years.

Building a Stable Future

SFCASA's goal is to serve 500 youth by the year 2027. This year, we supported 370 youth with relationship-based advocacy. There were 330 active CASA volunteers in San Francisco County.

We saw a lot of success and are working hard to reach our goals.

BY THE NUMBERS



The YOUTH Empowerment Board

As part of SFCASA's partnership with the San Francisco Human Rights Commission Dream Keeper Initiative, the SFCASA YOUTH (Youth Organizers United to Hone) Empowerment Board involves youth, ages 17-24, who are hired for a 12-month term. During the paid internship, Board Members address the structural inequities transitional age youth (TAY) face within San Francisco's dependency, juvenile justice and connected systems by establishing guidelines, reviewing and making funding decisions on youth grants. Grants for such things as housing, education and career supports range from \$500 to \$2500.

Board members collaborate with SFCASA's TAY Specialist on the grant program and a broader program to bring appropriate resources to the TAY community. Honoring their personal experiences, they bring youth voice to the larger community, informing decision-makers, including SFCASA staff and the Board of Directors, on challenges current and former foster youth encounter in the dependency and juvenile justice systems. This year, Board members presented to the SF Youth Commission, Human Service Agency- Family & Children's Services, and the full Board of Supervisors, in addition to SFCASA's board and staff. They also consulted on the design of SFCASA's new home on Mission Street.

During the 2022-2023 Fiscal Year, the Youth Empowerment Board made 40 grants totaling \$59,014 in awards. They learned at the end of their first year that the Human Rights Commission was renewing support for a second year.

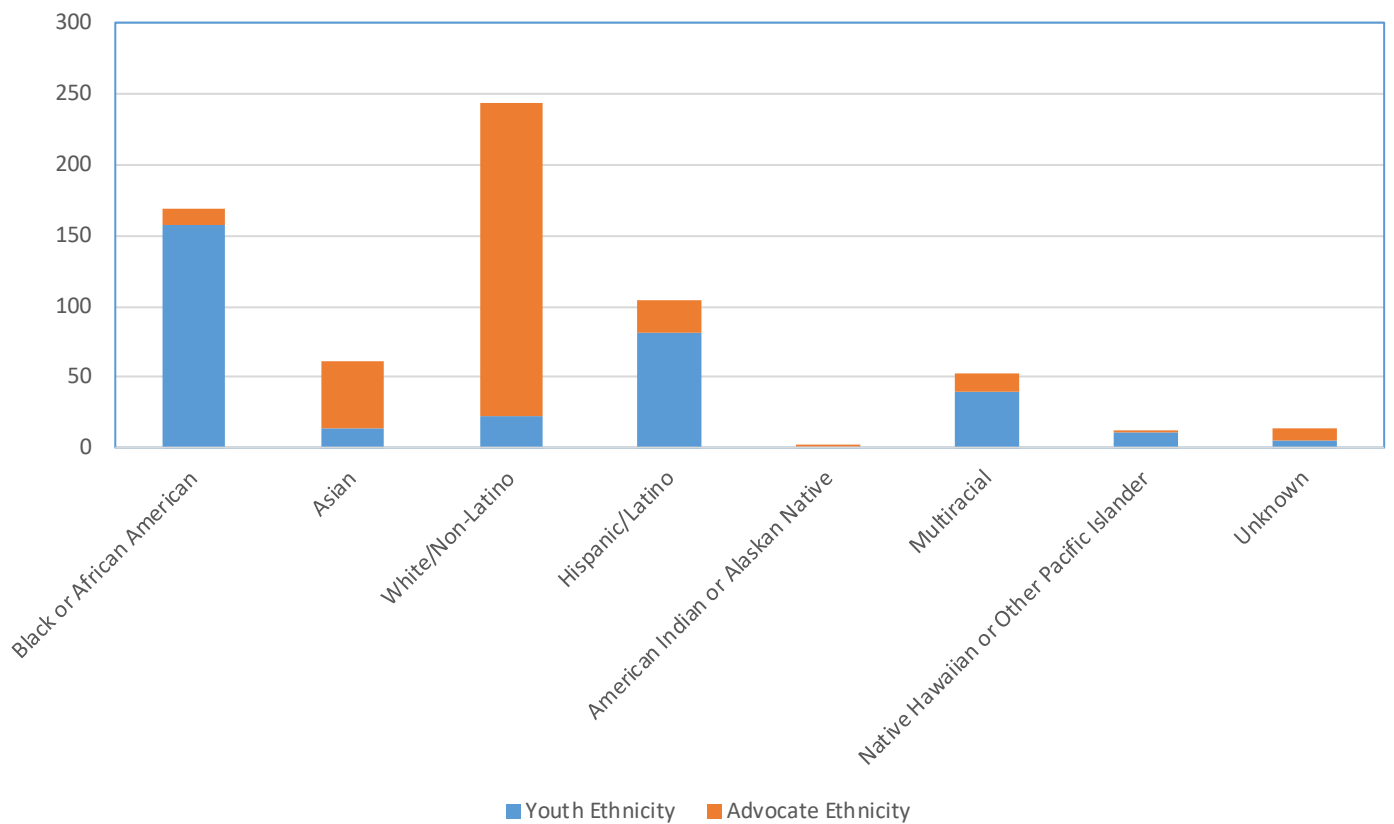

Spotlight: JP & Mallory

In 2022, JP received his first ever paycheck. While he was proud of his new job, there was someone else who was also cheering for him. His CASA Mallory had been by his side for over 4 years. During this time, she saw him grow, learn, and progress to be a wonderful and responsible young person.

With his new job, JP needed to file taxes. When JP and Mallory discussed ways that he could file a tax return for the first time, he recalled his friend had filed their taxes through TurboTax, and thought it would be a free service, but TurboTax took a significant portion of his returns as a fee.

After hearing this story, Mallory was determined to help JP file a tax return for free. She looked for free resources, even calling the IRS to get more information.

When Mallory found out that SFCASA would be starting the Youth Tax Project, JP and Mallory were ecstatic. JP signed up and became the first ever youth to participate in the Youth Tax Project in 2022.

When 2023 rolled around, JP wanted to participate in the Youth Tax Project again, telling Mallory how impressed he was by the helpfulness of the volunteers. JP also hadn't known about the new 2023 tax credit that is available for all foster youth in California - he had never expected to be walking away from his tax session with over \$1,000 in his pocket. While most youth need two or three sessions to complete their taxes, JP was able to get everything done in one 1.5 hour session because he had prepared all of his documents in advance.

For many, the tax credit was not just chump change. It helped them to pay for rent and other basic needs. The tax credit has helped youth like JP tremendously.

SFCASA Foster Youth Tax Project:

In hopes of facilitating financial justice through economic inclusion and poverty alleviation, SFCASA has started a Volunteer Income Tax Assistance (VITA) site. Since 2021, SFCASA's Foster Youth Tax Project has provided free tax filing services for current and former foster youth, ages 18-25.

Beginning in 2023 as an IRS certified VITA site, the 2023 Clinic served 42 young people and secured over \$80,000 in state and federal refunds. To learn more, please visit <https://www.sfcasa.org/tax-project>.

Foster Youth Tax Credit (FYTC):

The Federal Youth Tax Credit is available to current and former foster youth and families who meet the following requirements:

- Were ages 18-25 at the end of the tax year
- Were in California foster care at age 13 or older
- Qualify for the California Earned Income Tax Credit (CalEITC). The FYTC is a state credit tied to CalEITC.

Eligible individuals may receive up to \$1,083.

Strategic Priorities

SFCASA completed the first year of its new strategic plan in FY 22-23. The 5 year plan implements youth and family centered advocacy so that we can strengthen families to stay together, deepen support for young people in foster care, and sustain and support the well-being of young people beyond formal systems involvement.

By the year 2027, we hope to serve **500** youth annually. We will achieve this by:

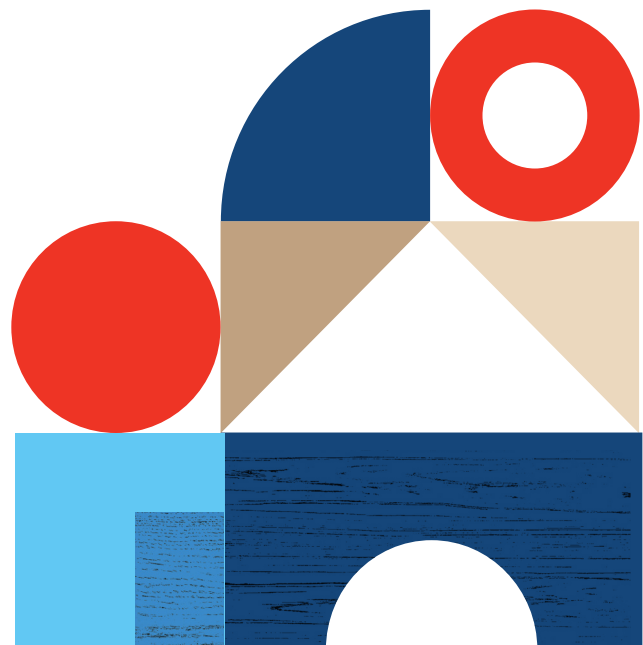
- 1. Strengthening families to stay together and prevent systems involvement;**
- 2. Growing in-care support and continue to advocate for equitable and expedient in-system outcomes for young people; and**
- 3. Providing post-systems support to sustain and advance individual and family agency, voice, wellness and community connections.**

During this first year of the plan, we relaunched the Fostering Futures Circle, with two new members naming SFCASA in their estate plans. The Fostering Change Gala: Be Brave raised \$1.25 million, \$110,000 over goal, with \$505,000 of that amount going to the coming year's budget.

We were successful in a very tough City budget year getting \$175K for SFCASA through the Supervisors budget process for fiscal year 23-24.

SFCASA VITA site prepared 51 returns (majority 2022 returns with some 2020 and 2021 returns to unlock unclaimed stimulus money) for 42 clients for a total of \$80,972 in state and federal refunds. SFCASA is committed to growing access to this poverty alleviation and economic inclusion programming with the addition of a new position focused on support for the FYTP and Continued Care/Aftercare program implementation

9 youth received total of 71 therapeutic riding lessons as part of Hanging with the Horses partnership with Brady Therapeutic Riding.

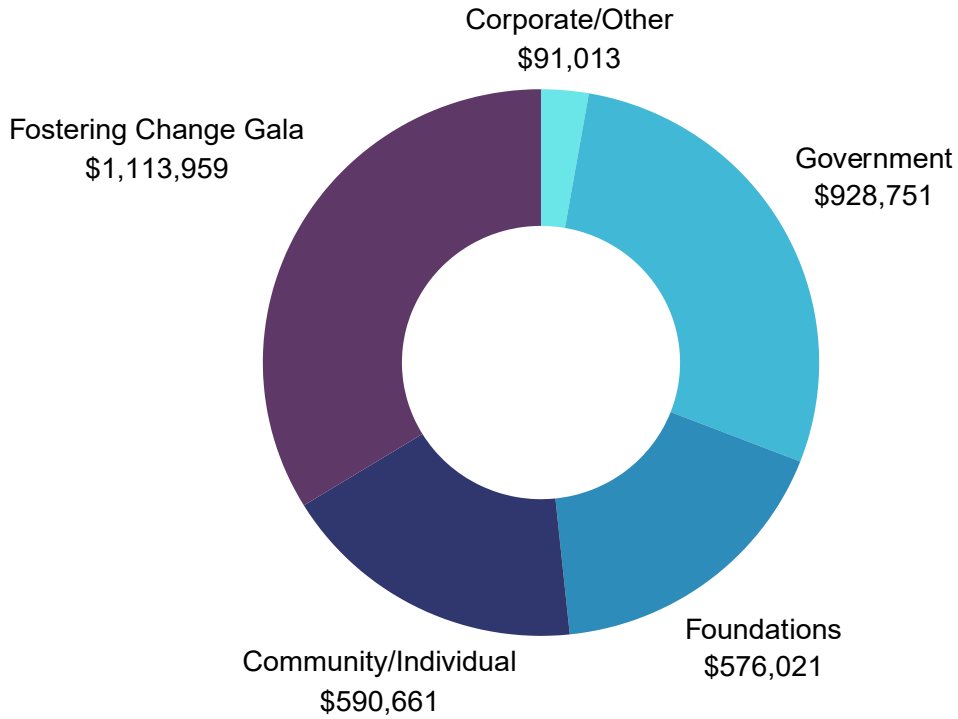

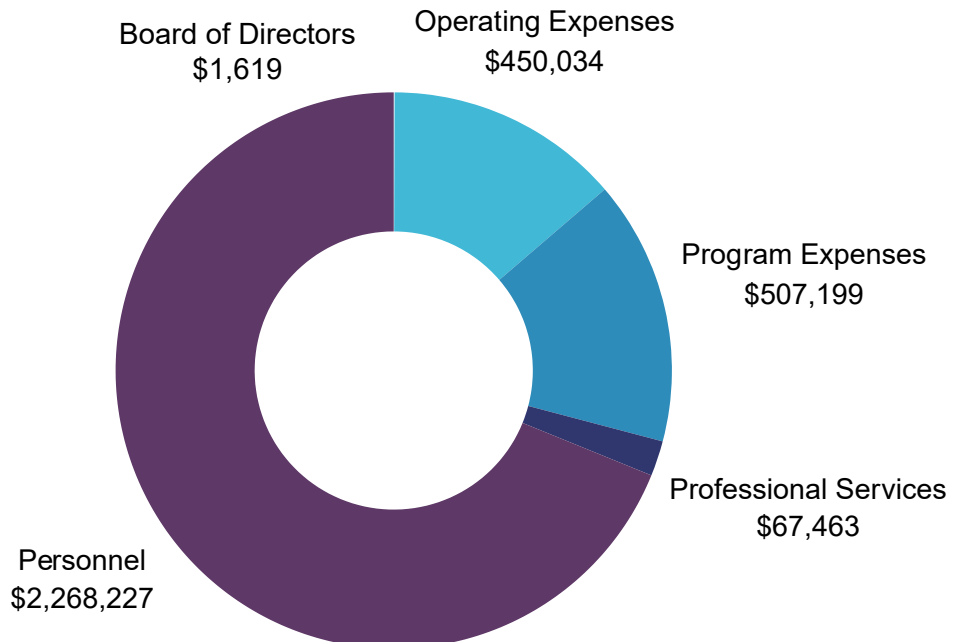
OPERATIONAL REVENUE
