San Francisco CASA transforms the lives of abused and neglected foster youth by providing one consistent, caring volunteer advocate, trained to address each child's needs in the court and the community.

SFCASA's 327 volunteers provided one-on-one mentoring and advocacy to 328 foster youth. CASA volunteers are sworn officers of the court, trained to mentor and advocate for the best interests of foster youth in the dependency system. They advocate through court reports submitted directly to the judge overseeing the case, as well as working directly with schools, social workers and healthcare providers. SFCASA implemented a first-of-its-kind impact measurement and learning system to more fully understand the progress of each youth and the impact of its advocacy and mentoring program overall.

4b (Code:) (Expenses \$ 27,062. including grants of \$) (Revenue \$)

Launched in July 2017, San Francisco CASA's Court Dog program provides a highly trained facility dog in the courtroom during Family Court proceedings involving foster youth and their families, helping to deescalate tensions and create a feeling of calm. "Nemo," a gentle Labrador Retriever, was expertly trained by Canine Companions for Independence (CCI) and is partnered with Nemo's facilitator and co-facilitator, both of whom completed an intensive training at CCI. Nemo goes to court 3 days per week and interacts with up to 25 youth and court visitors per day. Regular requests are received for Nemo's presence in court by attorneys who represent foster youth, and youth who have had Nemo present during a court visit almost universally ask to have him in attendance at all subsequent court appearances.
